## Conditions for the use of reproductions and for publication



1. Reproductions may only be used for the purpose stated in the request and for which authorisation has been granted. If the applicant wishes to use a reproduction already in their possession for publication purposes, they must reapply for authorisation from Mart.
2. The applicant undertakes not to transfer or sell the reproductions obtained under any circumstances.
3. Authorisation for publication is granted on a one-off, non-exclusive basis, for a single publication and one edition in one language. Subsequent editions as well as any use other than that for which authorisation was granted must be reauthorised by Mart.
4. **The applicant is in any case responsible for complying with all obligations towards the authors or rights holders before publication.** Mart accepts no liability for unauthorised use of the images and/or for any rights claimed by the author or the rights holders. The Museum is available for information regarding royalty payment and will provide the user with any information in its possession that may be useful for the purposes of ascertaining and paying copyright fees.
5. Reproductions intended for publication may not be altered, reduced, divided into parts, or overprinted (e.g. with lettering, colour, or other image) unless authorised by Mart. Reproduction of a detail requires prior approval from Mart and must be identified as such in the citation of the image. If the reproduction, or any part of it, appears on the cover or dust jacket of books, or on calendars, brochures, posters, or the like, the final draft must be approved by Mart before printing and distribution.
